OVERALL ASSESSMENT

Contribution

Veronika Sovičová wrote a very good master thesis on a timely topic of corporate social responsibility and tax haven use. This is currently a very intensively studied topics by leading scholars in economics, accounting and other related fields and, despite this, Veronika, managed to carve out a reasonably novel approach, a collection of data and new empirical results, which together constitute a modest, but good enough contribution for a master thesis.

In her thesis, Veronika finds evidence that firms using tax havens are more than 60% less likely to have higher corporate social responsibility score. While Veronika's main contribution is obviously empirical, the thesis is well balanced with a good non-empirical material included and, for example, she interprets one of her main finding cited above as being in line with the corporate culture theory (rather than the risk management theory). Veronika does not communicate what her main contribution is as strongly as she could and I would welcome a more explicit description of her contribution with respect to the existing academic literature.

Methods

Methodologically, Veronika's approach is adequate for a mater thesis, both in terms of the overall thesis as well as the empirical analysis.

Veronika collects the relevant data and seems to be competent in the data analysis and the results' interpretations. She also seems to be aware of some of the limitations of her empirical analysis and discusses some of them well in her thesis, which is welcome.

One of the limitations of the empirical analysis is indeed the focus on one region only. Was the focus on one region due to the time-consuming nature of the data collection or some other reason? Covering the whole of Europe or the world would increase the currently low number of observations as well as provide a natural comparison for the region Veronika seems to be interested in (highlighting differences across European regions rather than discussing results for one only). I do not see this is a crucial disadvantage (and other theses often take a similar approach) but I wish Veronika discussed this decision more explicitly in her thesis. (In addition, as Veronika notes in her thesis, this sole focus and collection results into a very small number of observations because "As CSR reporting is relatively less common in the Central and Eastern Europe, the number of corporations for which we managed to collect CSR performance data was also fairly limited.")

Literature

Veronika has done a very good enough job of understanding the literature and relating his research to the most closely related papers. She shows off this command of literature in her thesis very well.

While I am not an expert on corporate social responsibility, I am well aware of the excellent paper of Prem Sikka from 2010: Sikka, P. (2010, September). Smoke and mirrors: Corporate social responsibility and tax avoidance. In *Accounting forum* (Vol. 34, No. 3-4, pp. 153-168). No longer published by Elsevier.

I have thus wholeheartedly welcomed the fact that Veronika repeatedly cites and works with this influential paper.
