OVERALL ASSESSMENT (provided in English, Czech, or Slovak):

Short summary

The thesis tests the relationship between PPI and CPI. A lot of work has been put into the thesis, and I appreciate the careful analysis presented there. That said, I find the research question relatively strange, because in a way it is like testing the relationship between temperature measured in Celsius and temperature measured in Fahrenheit. In the end, it is the same thing, just measured differently, so I don't see what we learn from Granger causality tests such as those conducted in the thesis. In the long run, these two indices measure the same thing (well, perhaps not exactly, because of the potential systematic difference due to the treatment of the substitution effect – but this is a trivial issue, as the substitution effect should not change much with time).

In the short run, there might be differences, and indeed the short-run differences between PPI and CPI might be interesting for the central bank, because PPI can serve as a leading indicator for CPI. But if short-run forecasting performance is the goal, why not to develop a forecasting model, for example based on some form of model averaging? As far as I can tell, there is nothing wrong with the Granger causality modelling presented in the thesis, but I miss an explanation of why they are useful in practice or for further research.

Contribution

As I have mentioned above, I don't see much of a contribution compared to other BA theses I have seen – again, there is nothing wrong about the analysis presented here, but many BA theses defended at the IES approach the level of papers publishable in mid-tier international journals. This is clearly not the case here. This might have been an "A" thesis 20 years ago, but not today.

Methods

Standard time series methods are used. As I have noted, I believe these are correctly applied.

Literature

I don't see any problems with the way relevant literature is treated in this thesis.
