Short summary

In hir thesis Kryštof Zatloukal analyses success of tranfers of football players. In order to do so, transfers into Premier league that happend during 2020. The analysis shows that the better a player is performing before the transfer, the more successful his transfer is going to be. Furthermore, performance of the club, from which a player is transferring, has also shown to be a determinant of transfer success. The definition of success is simply the change in the market value of the player.

Contribution

The thesis follows previous studies that analyze trades, transfers, market value and performance of football players, but the analysis of success after transfer is a an original an innovative perspective and was so far overlooked. The analysis shows, that some factors can help to explain the success of the transfer.

Methods

The thesis follows standard methodology for this type of data and Kryštof shows that he is aware of the aspects of linear regression. The data collection process is also very well described. It is a bit pity, that the data about transfers are not collected from a more time periods as it might have been partially influenced by the covid-19.

Literature

All sources are well referenced, the author follows citation rules. Relevant studies from the area of football player analysis are summarized.

Manuscript form

The thesis itself is easy to follow and the formatting is done with care. From my perspective, more visual presentation of the data could be part of the thesis, as the data gathering process and dataset creation took a large amount of time and work and it is pitty that it is not better presented. Also, some larger tables could be formatted with even more care, but these are just minor details which not affect on the content.

Overall evaluation and suggested questions for the discussion during the defense

From the perspective of a supervisor, Kryštof was able to collect the data fully by himself and was creative when trying to find the best measure of the success of football players. We discusses that a few times and decided to stick with the current solution even if we are aware of the limitations. Kryštof worked on his thesis continuously and with interest for the topic itself. Since I had the opportunity to see the progress of the thesis, my key remarks were incorporated.

I do not have a specific question for the defense, and I would suggest that Kryštof elaborates about the possible measures of football player success and what are the advantages and disadvantages of the chosen measure.

The results of the Urkund analysis do not indicate significant text similarity with other available sources.
