Short summary

In hir thesis Lukáš Novotný collect large dataset from second-hand marketplace focused purely on board games. The marketplace is international, but for the simplicity of the analysis, it is focused on United States market. The dataset is analysed using OLS method to determine the drives of the price of a second-hand product. Second-hand markets are well developed and economic literature focuses on those, but it might be the first attempt to analyse second-hand board games.

Contribution

Lukáš collected the data from available sources using webscapping methods, since the BoarGameGeek platform does not provide the dataset for a download. The topic of board game is very original, but the marketplace as such is huge and the market for boardgames worldwide grows every year and from the most popoular titles, several thousand copies are sold every year. The analysis also provides a valuable information for those who want to sell something on a second-hand market, want to maximize the profit but also want to sell it in a timely manner.

Methods

The thesis follows standard methodology for this type of data and Lukáš shows that he is aware of the aspects of linear regression. The data collection process is also very well described. The modelling process is also well commented.

Literature

All sources are well referenced, studies used belong to the core of the studied topic. Relevant studies from similar topic (games) and method (hedonic pricing) are briefly summarized.

Manuscript form

The thesis itself is very well written, using standard template which is highly appreciated. From my perspective, more visual presentation of the data could be part of the thesis, as the data gathering process and dataset creation took a large amount of time and work and it is pitty that it is not better presented.

Overall evaluation and suggested questions for the discussion during the defense

From the perspective of a supervisor, Lukáš was able to collect the data fully by himself with only a few hints from my side and getting such data was not an easy task. Lukáš worked on his thesis continuously and with passion for the topic.

I do not have a specific question for the defense, but I would suggest that Lukáš elaborates about what would be his suggestion for buyers and sellers if they want to trade board games based on his analysis.

The results of the Urkund analysis do not indicate significant text similarity with other available sources.
