## **Evaluation**

## Major criteria:

This thesis explores the far-reaching effects of Boko Haram's use of gender-based violence against women as a deliberate tactic in northeastern Nigeria. It provides a comprehensive analysis of the impact of this violence on various aspects of the lives of women and girls in the region. Notably, this study offers a unique contribution by examining the influence of Boko Haram's gender-based violence on the position of women within local communities, as well as its spillover effects on other actors involved, such as the Nigerian military and aid workers. By doing so, it identifies Boko Haram as both a direct and indirect perpetrator of gender-based violence.

The thesis employs a skillful theoretical framework that combines the strategic rape theory and feminist theories, providing a comprehensive background for the empirical analysis. The author demonstrates a strong basis of data, including an interview conducted with the Nigerian Office of Amnesty International. It is worth noting the careful consideration given to ethical aspects in conducting the interview to obtain original primary data, particularly given the sensitive and complex security environment of Nigeria.

Overall, this research is commendable for its systematic and cohesive analysis, which is the first of its kind in this field. It fills an important gap in understanding the consequences of Boko Haram's adoption of gender-based violence as a semi-official tactic.
