Short summary

In his thesis, Artem Usov analyses the motion picture market in the Czech Republic from the perspective of box office performance - therefore, the most relevant part for the finance sector. The thesis tries to find the drivers of attendance and revenue performance of more than 1400 movies that were shown in Czech cinemas in the last decade. The study finds that movies of Czech origin perform better, and so do also movies featuring known actors and actresses.

Contribution

The thesis uses a combination of sources that provides it with a unique dataset, but since it focuses just on a specific sample of movies, the results cannot be used generally in the movie industry, but only with care. But, since the results also confirm previous findings in similar academic studies, the study does focus on the relevant part of the market and is valuable from the economics and finance perspective.

Methods

It would be beneficial if the movie selection process would be better described in the thesis. Data availability is the key issue, but readers can ask if e.g. every movie shown in the cinema is in the dataset or what the limitations are. The cross-sectional dataset is then analyzed using OLS regression, and assumptions are tested. The database used for the thesis required a combination of several different sources and a great portion of data cleaning.

Literature

The literature overview covers existing literature and also provides a summary of existing results, which are mostly verified by the empirical part. The literature is used and cited properly according to academic standards.

Manuscript form

The thesis is well structured and formatted using a standardized Latex template. The language used is easy to understand. The thesis could be improved by looking at the data more visually - if some relationship between dependent and independent variables is obvious or not. I do not mean adding visualization to each of the independent variables, as it would not serve the purpose.

Overall evaluation and suggested questions for the discussion during the defense

From the perspective of a supervisor, Artem worked on the thesis continuously and, started with data gathering early and had first results quite soon. I could provide my comments over time so the interpretation of the results is significantly improved in the final version, and possible limitations are discussed as well. I appreciate the work connected to the data collection and cleaning and also the different ideas Artem had while analyzing the data.

My evaluation reflects the fact that the thesis could be improved by some sort of robustness check or additional analysis using only part of the date or data selection method. It would support the current results or might provide additional findings.
