The thesis is well-structured. The writing is coherent and maintains an academic writing style and terminology. The referencing style and citations are correct.

### 4. OVERAL EVALUATION (provide a summarizing list of the thesis's strengths and weaknesses):

Eric Raup's MA diploma thesis presents original research results in the fields of journalism studies and visual communication. The author examines the visual commemoration of a significant historical event within the context of the social network Instagram, with a specific focus on quality news outlets and their utilization of visual narratives to shape cultural history.

The study's objectives and aims are both clear and coherent. The thesis is built upon a thorough literature review and a theoretical framework rooted in a constructivist approach. This framework argues that media outlets and journalism play a pivotal role in constructing social memory. As part of this process, social networks become powerful tools. However, as highlighted by Eric Raup, limited attention has been paid to content analysis of the construction of remembrance on Instagram's news outlets coverage. The thesis thus bring original findings that possess the potential to address a gap in the contemporary state of research.

Eric Raup employs a qualitative approach, specifically utilizing the relatively novel Multimodal Critical Discourse Analysis methodology. This approach enables him to delve into the subject of collective memory and explore how narratives are shaped by dominant discourses through mass communication. The candidate employs a systematic approach and encompasses various media outlets with diverse backgrounds and origins. Such an inclusive approach allows for a deeper understanding of dominant discourses concerning the narratives of the Fall of the Berlin Wall across different cultural backgrounds.

The final discussion presents several dominant discourses that align with the results of other scholarly studies, thereby enriching the discourse on how these dominant discourses are replicated and reinforced.

In conclusion, the presented thesis demonstrates outstanding quality, and therefore I suggest evaluating it with a grade of A.

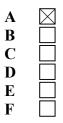
