1. Is the aim of the thesis (research question) formulated clearly? Do the conclusions answer the research question?

Yes, the aim is stated clearly and answers the research questions outlined in the thesis. The thesis aims to study the causal effect of time perspectives on pro-environmental behavior and attempts to answer this by conducting experimental studies.

2. Is the thesis structured appropriately? Do the subsequent parts of the text follow each other coherently? Is the text factual and logically consistent?

The thesis is structured in standard format, into three parts with clear divisions, including theoretical background, pilot study, main study, and general discussion.

3. Is the thesis clearly related to the chosen thematic areas of the final state exam (FSE) in sociology, specialisation and methodology? Are the passages related to the chosen areas integrated in a coherent way into the thesis?

The thesis relates to the thematic areas of FSE by focusing on environmental identity, but the connection between globalization and identity has to be elaborated. The overall integration appears coherent.

4. Do the sections of the thesis, in which relation of the thesis to the state thesis topics is developed, prove a sufficiently deep knowledge of the studied topic, problem or phenomenon on its theoretical or methodological level? Is the knowledge of the chosen thematic area of the FSE appropriately presented in the analysis and in the formulation of the conclusion of the thesis?

The thesis demonstrates deep knowledge of the theoretical constructs and methodological approaches, particularly in the context of pro-environmental behavior and time perspective manipulation. The representation and development of the other thematic areas are limited in conclusion.

5. Does the author refer to a sufficient amount of literature relevant to the topic of the thesis? Does he/she refer to texts published in English or other languages (other than Czech only?

The thesis references include a range of literature and an extensive list relevant to the topic, including works published in English.

6. What is the quality of the data or sources used (including their selection, collection, and description) and their analysis methods?

Data collection follows open science principles, ensuring transparency and reliability. The online data collection method provided a representative sample for the study, which entailed experiments for data extraction. Analysis methods entailed standard statistical procedures and R software appropriate for testing hypotheses and the research questions.

7. What is the quality of the arguments on which the author supports his/her conclusions?

The arguments are well-supported by empirical data and theoretical background, indicating a strong foundation for the conclusions drawn. The study refers to previous studies on the subject, strengthening the methodological aspects of the thesis.

8. Are the author's arguments and findings clearly distinguished from those taken from other sources? Are the machine generated parts of the text clearly identified in the thesis, with reference to their source?

The document does not indicate machine-generated text; arguments are attributed to their respective sources with proper citation. The author declared the use of DeepL, Grammarly, and ChatGPT for proofreading services and GPT for R analytical script.

9. What is the quality of reference apparatus, language, and other formal requirements?

The references are fairly cited, and the language is clear and academic in tone, meeting the formal requirements of a thesis. A few parts in the introduction are repeated and can be rectified.

Overall, the thesis is well-written. It demonstrated originality and a fair grasp of the main theme, theoretical and methodological framing, and presentation of the results.
