## **Short summary**

In her thesis, Anežka Neckářová studies intra-household consumption inequality in Nigeria. For that purpose, she combines household-level survey data with a recently proposed methodology, which enables her to recover the resource shares consumed by males, females, and children. The author's findings suggest a considerable level of gender inequality in favour of women. However, these lack statistical significance for households with children and thus have to be interpreted cautiously.

#### Contribution

The main contribution of the thesis lies in the application of a novel methodology to a new dataset. This combination enables the author to contribute novel evidence on the long-standing issue of intrahousehold consumption inequality. The thesis is a replication of Lechene et al. (2022) on a more recent dataset.

Given the difficulty of the method, combined with the necessary work involved in processing the household-level microdata and the overall relevance of the topic, I believe that this constitutes a contribution that far exceeds the level expected from a bachelor thesis.

### Methods

To estimate the resource shares, the author relies on linear reframing of the collective household model, which was recently proposed by Lechene et al. (2022). Thanks to the linear nature of the proposed method, she relies on SURE to estimate Engel curves for assignable goods, i.e., male, female, and children's clothing, which then enable her to recover estimates of resource shares.

This methodology is in line with the current empirical research and significantly above the author's level of studies as it required getting acquainted with the collective household framework.

### Literature

The author provides an accessible review of the relevant literature. While some recent empirical studies are missing, all major works are referenced.
