CONTRIBUTION:

The contribution of the thesis is as follows. (i) First, it discusses and then uses novel machine learning methods to explore the relationship between sentiment and asset returns. (ii) Second, it uses these methods to compare the passthrough of sentiment shocks to asset returns across countries in the Western Hemispehere..

METHODS:

The student exploits established together with frontier methods, well beyond the requirements of a master thesis.

LITERATURE:

The thesis is well placed within the cited literature. The literature review is comprehensive and well discussed..

MANUSCRIPT FORM:

The thesis is well written, but the presentation of the main exhibits lacks clarity. The thesis would benefit from more informative figure and table captions, as well as a better explanation of the implications of the main results.

SUMMARY AND SUGGESTED QUESTIONS FOR THE DISCUSSION DURING THE DEFENSE:

This is a good quality diploma thesis in terms of both empirics and estimation techniques.

During the defense, I suggest asking about the role of the exchange rates in affecting cross country results. I noticed, in fact, that the Brazilian assets have exceptionally high returns, but in a period of strong appreciation of the real (the Brazilian currency) with respect to the dollar.
