#### Short summary

The thesis uses a panel of countries to examine how different types of financial crises affect wealth inequality. It uses several standard regression specifications of the determinants of wealth inequality. The thesis finds that some types of financial crises matter for wealth inequality.

## Contribution

The contribution lies in the examination of the determinants of wealth inequality. Considering the importance of the concept of inequality in social sciences, it is surprising that there are only a handful of relevant empirical studies. To a certain extent, the lack of studies examining the determinants of wealth inequality is caused by the difficulty of obtaining relevant data. However, this is no longer the case and there are some data on wealth inequality available.

To my knowledge, nobody systematically examined the effect of financial crises (banking, currency and debt crises); this makes the thesis unique. Hasan, Horvath and Mares (2020, Journal of International Money and Finance) examine the effect of financial development on wealth inequality and Shchepeleva, Stolbov and Weill (2022, International Economics) investigate the role of global financial crisis on wealth inequality. Both these studies use the same measure of wealth inequality as this thesis but both studies examine a different research questions.

## Methods

The author uses standard panel data methods such as fixed effects and discusses the eventual endogeneity issues in detail. The author had to collect data by himself and form a relatively extensive panel dataset.

## Literature

The literature coverage is extensive and I think all important relevant studies are discussed.

## Manuscript form

The manuscript form is adequate. The thesis is structured logically.
