What are the strengths and weaknesses of the thesis? Please give your reasons for the suggested grade in detail below.

1. Does the author show understanding of one or more theories, and use theory to generate a hypothesis or to make the problem area more understandable.

Comments:

This MA thesis examines the relationship between new media and urban life, focusing on the digital representation of Tehran's Lowlagar Alley on Instagram. By analyzing 48 posts, the study reveals that Instagram portrays the alley through an aesthetic and nostalgic lens, often promoting it as a location tied to luxury consumption and lifestyle construction. The research highlights Instagram's role in commodifying urban spaces, showing how digital platforms sell both physical locations and aspirational lifestyles. The thesis raises important questions about how social media reflects unique urban characteristics and how these representations align with global trends in the commodification of urban spaces.

The thesis is theoretically robust, drawing upon relevant theoretical sources to effectively shape the research questions and hypotheses. The author has demonstrated a commendable and inventive approach to the topic. Drawing inspiration from recent studies, particularly the work on Amsterdam, she has adeptly focused on several key aspects of contemporary urban studies, such as the commodification of space, gentrification, and the consumption of experience. As her supervisor, I was highly impressed with her work. She took my advice to identify and engage with recent studies most relevant to her research, thoroughly analyzing them and creatively adapting their insights to further her own focus. I consider this thesis to be one of the most theoretically innovative among those I have supervised in recent years.

2. Is the research question articulated clearly and properly? Is the research question sufficiently answered in the conclusion?

Comments: There are two main research questions: 1) How is Lowlagar represented on Instagram, and what dominant themes and elements characterize these digital representations?

• Research Question 2) To what extent do the digital representations of Lowlagar on Instagram reflect unique aspects of the city, and how do they align with broader global trends in urban representation on social media? Yes, they are a constant presence and focus





throughout the entire thesis, and the conclusion provides a coherent account and discussion of the findings.

3. Is the thesis based on relevant research and literature and does it accurately summarize and integrate the information?

Comments: Yes, I consider the selection of the main references to be one of the strongest merits of the thesis.

4. What is the quality of the data or the other sources? Are the sample method, data collection and data analysis appropriate?

Comments: The research design is well-suited to the objectives of the study and appropriately adjusted to the opportunities and constraints of student research. The research process is described adequately.
