1) Contribution and argument:

The author submits a very original and highly up-to-date diploma thesis for defense. At first glance, the issue of subversion does not seem like a geopolitical topic, but I believe that the author succeeded very well in showing that it makes sense to focus geopolitical analysis in this direction as well. At the same time, I very much appreciate that and how the author took inspiration from the past, from the approach that was once applied by the Soviet Union and related it to the present and Chinese practices.

2) Theoretical and methodological framework:

The entire 1st chapter of the thesis is devoted to the theoretical foundation. The author convincingly argues why he chose several theoretical approaches, which are then properly explained and applied to the researched topic.
