Summary assessment/comments

Overall it's a solid work on the timely topic

The thesis looks at a highly relevant topic of populist foreign policy towards China and it presents two case studies from Central Europe:

Poland and Hungary.

The research puzzle, framework and theoretical framework are properly defined and explained.

There are some inconsistencies and shortages when it comes to clarity (it's not sure from the beginning what the timeframe is) and

surprisingly, the literature review omits works on exactly the same topic such as: Kopper, Akos, Szalai, Andras and Góra, Magdalena (2023).

Populist Foreign Policy in Central and Eastern Europe: Poland, Hungary and the Shock of the Ukraine Crisis. In: Giurlando, P., Wajner, D.F. (eds)

Populist Foreign Policy. Global Foreign Policy Studies. Palgrave Macmillan, Cham. Also, the discussion about the CEE specifics of populism could

be more elaborated and include authors conducting research on that area for years. There is a reference to Eurosceptic populism but barely

any literature on this phenomena is discussed.

Application of knowledge and insight

The structure of the work is clear, the concepts are applied properly. The methodology chosen by the Author is foreign policy analysis (FPA)

and process tracing which is explained in detail but not rigorously applied later. It may leave the impression that the methodological

framework was not fully applied to the study. The author states that the aim of the thesis "is to investigate the impacts of populists on the

decision-making bodies" but the measurement of the "impact" remains quite general - the reader is not informed what types of

documents/policies the Author assessed and how it was done. The descriptive part of the thesis (PL and HU relations with China) would

benefit from more examples of the impact of populism on FP-making.

Reaching conclusions

The conclusions are clear, well written and follow the requirements. The limitations of the research are rightly pointed out. The thesis question

is answered although there are some short comings when it comes to the hypothesis - the final conclusions could be more elaborate and

follow the structure proposed in the methodological part.
