Průběh zkoušky: The Defense Committee Chair welcomed present committee

members and all participants that joined the defense.

The Defense Committee Chair initiated the defense by verbal statements confirming (i) that a satisfactory number of Defense Committee Members were present, (ii) that the student fulfilled all the requirements as listed in the Study and Examination Code of

Charles University.

The Defense Committee Chair introduced all committee members and asked Josef Bajzík to present his dissertation thesis. Josef Bajzík shortly described the main findings of the dissertation. Afterwards, Josef Bajzík focused on the 3rd chapter called "Bank Capital, Lending and Regulation: A Meta-analysis" in more detail. After reading the referees' (appointed by the Graduation Council)

After reading the referees' (appointed by the Graduation Council) comments, an open discussion followed. During the discussion, Josef Bajzík satisfactorily answered all the questions from the audience.

Question: After the summary of the opponents' reports Answer: He thanked everyone for the nice words from the opponents.

Question: When working within CNB, can Josef draw conclusions towards the bank sector? Is it useful?

Answer: The results of the research are discussed with the

departments of the Czech National Bank, the board of the bank and the governor. The meetings continue even now. Whether they use the results, it is up to the board.

The committee members were satisfied with the answer.

Question: What is the most difficult thing within Josef's research? Answer: When working on meta-analyses, you need to sit and work a

lot. You go through articles one by one, then you code it and it takes a lot of time to collect the data. So you know the data well. But not a lot of people are willing to spend so much time with data collection. The committee members were satisfied with the answer.

Question: Hard questions are usually asked during the pre-defense, so a committee member is interested what recommendations would Josef give to PhD students for their PhD studies.

Answer: The relationship with the supervisor. He would try to be a TA for the supervisors' subjects.

The committee members were satisfied with the answer.

Question: Some papers were published by the Central Bank, some not. The estimated coefficient on the elasticity was sometimes lower or higher for some indicators. Can he explain why?

Answer: The effect was higher for CB papers but just for one indicator. For the other two indicators, there was no significant effect found.

The committee members were satisfied with the answer.
