Filip Matějka: What does "Segmented Labor" mean in your work?

Krešimir Žigić: Is it skilled vs. non-skilled? Is unskilled rigidity

much bigger than the skilled? Dušan Stojanović answered.

Filip Matějka: What is the form of government spending in the model?

Ctirad Slavík: What about wasteful spending?

Dušan Stojanović answered.

Krešimir Žigić: Do we really observe the recessionary impact of government spending in real life? So, in some situation this really happens, right?

Marek Kapička: 95 percent of the literature says that it is

expansionary.

Krešimir Žigić: Exactly.

Dušan Stojanović commented.

Filip Matějka: The benchmark can be that government does something, and nothing happens. It depends how it effects your beliefs. For instance, the multiplier effect is positive in the literature, and when government finance is weak, so that there is some probability of bankruptcy, expansionary policy can actually have a negative multiplier effect. Because they say the spending goes up, the probability of bankruptcy increases, I should start saving myself because I will not get any pension. So, it depends on these details.

On chapter 3:

Michal Franta: I am surprised by the persistence of the shock. It is statistically significant over the whole horizon. What about the trend? If the shock is persistent, it is not surprising that the other variables are persistent too.
