COMMENTARY:

The thesis aims to analyse reasons behind fragile governmenal establishment in Lebanon in the post-civil war years through describing the nature and actions of individual Lebanese governmets. It has achieved its objectives of "indicating factors of good governance specific to Lebanon ... to avoid political deadlocks and stabilizing the country's situation". The topic proves to be highly relevant given the ongoing Middle East turmoil.

The thesis does not omit any important aspect related to the need to comprehensively address the outlined issue. Slight imperfections are related to the structure; especially the introductory part may mislead the reader and bring the attention away from the importance of the subject. It would be preferable, if the thesis first outlined its objectives and methodology, leaving the topic overview (pages 4-7) as an attachment to the document. Also the historical chapters could be written in a more dynamic way. However, the work reaches the standard of quality expected for the mark it has obtained below.

2. QUESTIONS FOR THE DEFENSE

Normally it is considered that state has a monopoly over violence: in which way has this lack of monopoly affected the stability of the Lebanese institutions? And what solution would you propose?

Your thesis suggests that it may be a solution to avoid the ethical representative system: how do you think such a system would affect Lebanon?

Optional question:

The thesis acknowledges in its conclusion that "Lebanon continues to this day to operate in a system of political confessionalism" – although the major emphasis is related to domestic political and societal aspects, the regional development also play a role. Could you elaborate on the Syrian role in the Lebanese politics (also in light of the current political unrest)?
