Title of the thesis:	Repealing NAFTA: The impact on international trade with focus on Mexico

#### **OVERALL ASSESSMENT:**

**Contribution:** The author's main contribution is quantifying the repeal of NAFTA in terms of changes in tariffs rates: going from NAFTA to Most Favourable Nation tariffs. The performed analysis works well to estimate the impact of the NAFTA repeal. Although I believe that the macroeconomic implication of such event could be covered a bit deeper: the author discusses mostly GDP and investment, while other factors like labour market are insuficiently spread light on. Also, I find the confusion section relatively short. Nevertheless, I consider Author's contribution to be a strong one and adequate for a Bachelor Thesis.

**Methods:** The Author uses appropriate methodology for analysis of implications of trade agreement – the Computable General Equilibrium Model, more exactly, GTAP model. In my opinion the choise of the model is correct, especially as is it works with a global database that is updated periodically by a network of researches. The Author is using only tariffs changes as a policy change result. Although I consider that it is highly unlikely that the repealing of NAFTA will only affect trading tariffs, I understand that such an assuption (with the explatations provided in section 4) is sufficient for a research for a Bachelor Thesis.

**Literature:** The literature review is comprehensive, and allows a good introduction in the matter even for a reader outside this field. The background of NAFTA and its implications and sufficiently presented. The methodological part of the thesis is well documented as well. Unfortunatelly the thesis foes not reffer to some of the most recent studies in this field (ie Ciuriak, Dan, et al. "Quantifying the Termination of NAFTA." (2017) or Liu, Jonathan. "The Economic Impacts of a US withdrawal from NAFTA: A CGE Analysis." Undergraduate Economic Review 14.1 (2017): 14.)

**Manuscript form:** The manuscript form looks very academic, is facilitating easy reading and navigation of the paper, and is satisfying the requirements towards a Bachelor Thesis format.

Summary and suggested questions for the discussion during the defense: In case of a successful defence, I recommend grade "A".
